Your privacy is important to us

It is WAGGY MAMAS' policy to respect your privacy regarding any information we may collect while operating our website. This Privacy Policy applies to WAGGY MAMAS (hereinafter, "us", "we", or "WAGGY MAMAS"). We respect your privacy and are committed to protecting personally identifiable information you may provide us through the Website. We have adopted this privacy policy ("Privacy Policy") to explain what information may be collected on our Website, how we use this information, and under what circumstances we may disclose the information to third parties. This Privacy Policy applies only to information we collect through the Website and does not apply to our collection of information from other sources.

This Privacy Policy, together with the Terms of service posted on our Website, set forth the general rules and policies governing your use of our Website. Depending on your activities when visiting our Website, you may be required to agree to additional terms of service.

1. Website Visitors

Like most website operators, Company collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. WAGGY MAMAS's purpose in collecting non-personally identifying information is to better understand how WAGGY MAMAS's visitors use its website. From time to time, Company may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Company also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on https://waggymamas.com.blog.posts. Company only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below.

2. Personally-Identifying Information

Certain visitors to WAGGY MAMAS's websites choose to interact with Company in ways that require Company to gather personally-identifying information. The amount and type of information that Company gathers depends on the nature of the interaction. For example, we ask visitors who leave a comment at https://waggymamas.com to provide a username and email address.

3. Security

The security of your Personal Information is important to us, but remember that no method of transmission over the Internet, or method of electronic storage is 100% secure. While we strive to use commercially acceptable means to protect your Personal Information, we cannot guarantee its absolute security.

4. E-commerce

Those who engage in transactions with Company – by purchasing WAGGY MAMAS's services or products, are asked to provide additional information, including as necessary the personal and financial information required to process those transactions. In each case, Company collects such information only insofar as is necessary or appropriate to fulfil the purpose of the visitor's interaction with Company. Company does not disclose personally-identifying information other than as described below. And visitors can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.
